1. Date, Time and Venue of Annual General Meeting (“AGM”)

2. Registration on the day of the AGM

- i. All members, proxies, corporate representatives and attorneys are required to register their attendance on the day of the AGM at the registration counters for verification of their eligibility to attend the AGM.
- ii. Registration will commence at **8.30 a.m.** on the day of the AGM and will end upon announcement by the Chairman of the AGM. Registration counters are located before the entrance to the Greens III Sports Wing Event Hall. Members are advised to be punctual.
- iii. Please present your original MyKad or Passport (for foreigners) during the registration for verification purposes. No photocopy of MyKad or Passport will be accepted. Please note that you are not allowed to register on behalf of another individual, even with the original MyKad or Passport of that individual.
- iv. Upon successful registration of attendance, you will be given an identification wristband printed with barcode for entry to the meeting hall and voting access. If you are attending the AGM as a member as well as a proxy, you will be registered once and will be given only ONE identification wristband. Please note that you will not be allowed to enter the meeting hall without wearing the identification wristband. Please retain your identification wristband for voting. There will be no replacement in the event you lose or misplace your identification wristband.
- v. The registration counters are strictly for verification of identity and registration purposes. If you have any enquiries or clarifications, please proceed to the Help Desk.
- vi. If you have submitted your proxy form(s) and subsequently decide to appoint another person or wish to participate in the AGM by yourself, please write to eservices@sshsb.com.my to revoke the earlier appointed proxy twenty-four (24) hours before this Meeting.

3. PROXY

However, light refreshments will be served prior to the AGM, and a bento packed lunch will be available for takeaway after the meeting.

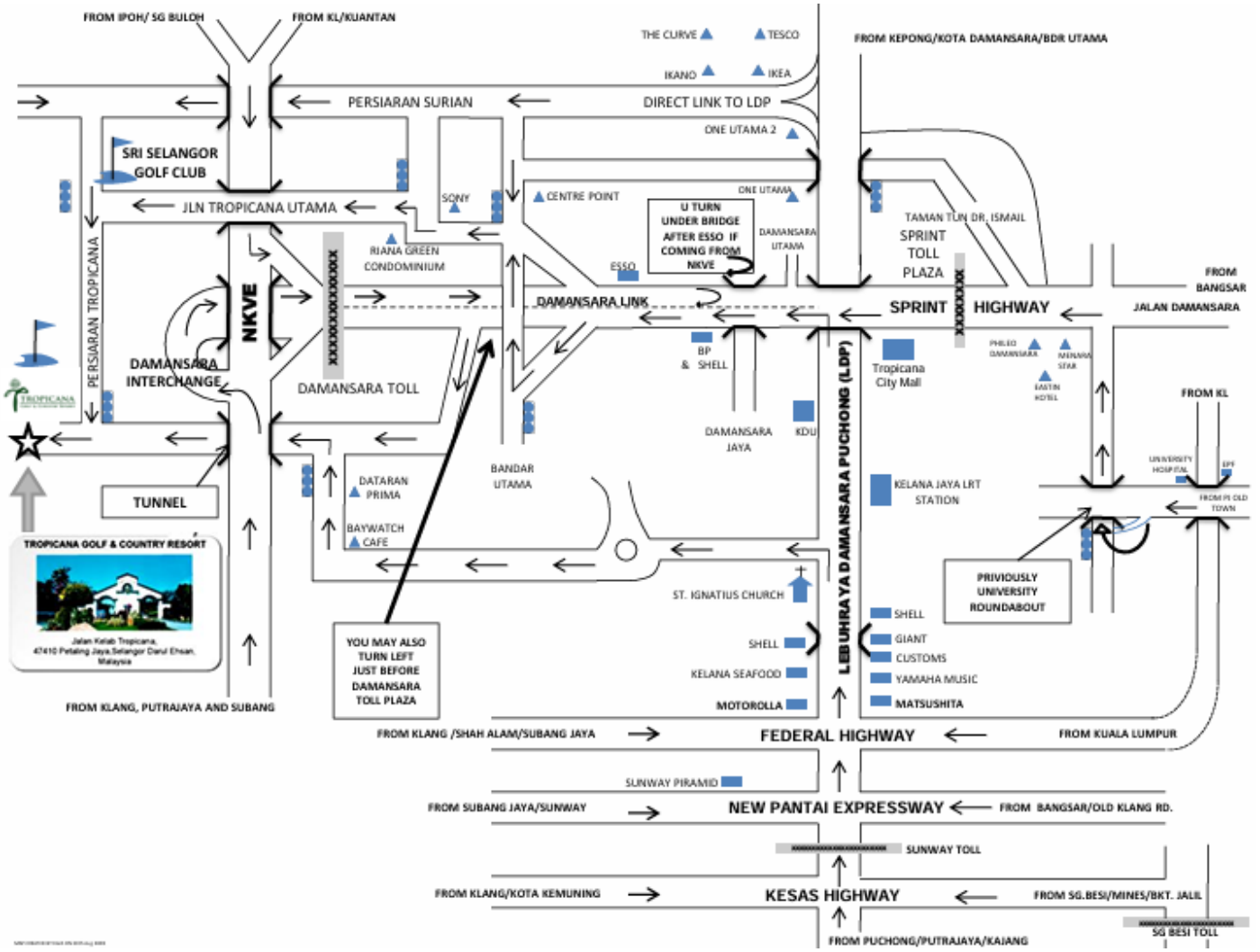
7. MOBILE DEVICES
